## MILES REGULAR COUNCIL MEETING DECEMBER 6, 2023 AT 6:00 P.M. MILES CITY HALL

Mayor Daniel Ernst called the regular session on December 6, 2023 at 6:00 p.m. at City Hall. PRESENT: R. Lawrence, M. Leamy, N. Corlis, N. Abernathy, and D. Chrest. Mayor Daniel Ernst presided. Motion carried.

APPROVAL OF AGENDA - R. Lawrence made a motion to approve the agenda as presented, seconded by M. Leamy. Motion carried.

CITIZENS/PUBLIC COMMENTS - None

GUESTS: Brittany Volquardsen, Laura Horst, and Paul Maze.

CONSENT AGENDA- M. Leamy made a motion to approve the consent agenda, including the minutes of the previous meeting, paid, unpaid, financial statements, water, sewer, and maintenance reports, seconded by council D. Chrest. Motion carried.

## **NEW BUSINESS**

Up for discussion, the city hired JCLL Enterprises (Rodney Gravel) to perform sewer samples at the old lagoon for the City of Miles while the construction of the new lagoon was on going. (Which required a WW Grade II Operator Certification). With the new lagoon operating in full force, the city no longer needs a WW Grade II Certification to perform sewer samples, therefore the city can fall back on Paul Maze, WW Grade I Certification to perform those samples. N. Corlis made a motion to terminate contract with JCLL Enterprises, seconded by M. Leamy. Motion carried.

City Clerk applied for the ICAP Grant (\$1000.00) and was awarded the money to be used for security camera's for the new playground equipment at the park. Miles Community Group suggested the camera's be installed to prevent any vandalism. The quote the city received from the Miles Telephone Co. was 1439.98. Clerk is asking for a motion to purchase these security cameras and to be installed at the park and use ICAP Grant and splash pad fundraising money. N. Abernathy made a motion to purchase the security camera's from Miles Telephone Co. and use ICAP Grant and splash pad money, N. Corlis seconded the motion. Motion carried.

N. Corlis made a motion to approve Payment #1 to Lansing Brothers Construction for the deconstruction of 346 Ferry Rd. in the amount of \$9000.00, motion was seconded by M. Leamy. Motion carried.

Maintenance employee (Paul Maze) was approached by a resident requesting a security light to be installed in the area behind Lincoln Street in the alley only because it's very dark. Paul informed the resident since it's a monthly charge to the city it will have to go before the council's approval. Before the council is a resolution pertaining to that request. D. Chrest made a motion to approve Res. 2023-20, A Street Light Resolution to be installed by Alliant Energy, seconded by N. Corlis. Motion carried.

M. Leamy made a motion to approve Payment #19 to Connolly Construction for the Wastewater Facility Project in the amount of \$52,435.25, D. Chrest seconded the motion. Motion carried.

Clerk informed the council the Employee Handbook was revised due to clarification of pay scale and holiday time off. M. Leamy made a motion to approve Res. 2023-19, A Resolution to approve the Employee Handbook, seconded by R. Lawrence. Motion carried.

Mayor Daniel Ernst, Paul Maze, Brittany Volquardsen, and Laura Horst left the meeting at 6:15 p.m.

Mayor Pro-Tem Nancy Corlis took over the council meeting.

Mayor Pro-Tem Corlis asked for a motion to go into closed session. N. Abernathy made that motion, seconded by D. Chrest at 6:17 p.m. Per Iowa Code 21.5(1) (i) to evaluate the professional competency of an individual whose

appointment, hiring, performance, or discharge is being considered when necessary to prevent needless and irreparable injury to that individual's reputation and that individual requests a closed session. Motion carried.

Entered into closed session.

M. Leamy made motion to entered into open session, seconded by N. Abernathy at 6:29 p.m. Motion carried.

Motion by D. Chrest to interview the 3 candidates, seconded by M. Leamy. Motion carried.

Motion by N. Corlis to conduct a special meeting to interview candidates on Wednesday, December 13, 2023 starting at 6:00 p.m., seconded by R. Lawrence. Motion carried.
